

RESOLUTION OF THE PAPAGO TRIBAL COUNCIL  
(Appointment of Directors of Management  
Board of Papago Farming Authority)

RES. NO. 121-80

1 WHEREAS, the Papago Council did by Resolution 72-79 establish the Papago  
2 Farming Authority and adopt a Plan of Operation granting management  
3 power to a Management Board of eight persons, five of whom must be  
4 members of the Papago Tribe and three of whom must be persons having  
5 not less than 3 years experience in farming or business management  
6 of substantial character; and

7 WHEREAS, The Papago Council did by Resolution 72-79 also appoint the following  
8 members of the Papago Tribe to the Management Board, to wit:

9 Tony Felix  
10 Gleason Norris  
11 Edward Manuel  
12 Bert Enos  
13 Laurence Jose

14 and did delegate to the Chairman of the Papago Council authority, with  
15 the advice and consent of the aforementioned directors, to appoint  
16 three additional directors with the management qualifications required  
17 by Section 8 B(2) of the Plan of Operation; and

18 WHEREAS, the Chairman did so appoint Arthur Pacheo, Jr., W. W. "Pat" Garrett  
19 and Brooks Taylor to the Management Board; and

20 WHEREAS, the Papago Council did on November 28, 1979, appoint Archie Hendricks  
21 to the Management Board to take the place of Laurence Jose who had  
22 resigned because he had taken a position with the Bureau of Indian  
23 Affairs; and

24 WHEREAS, all of the aforementioned directors of the initial Management Board  
25 were appointed for a period of one year, and it is necessary under  
26 Section 8 C(2) of the Plan of Operation for the Council to designate  
27 a new Management Board in three groups, the first group of three to  
28 serve one year, the second group of three to serve two years.

29 NOW, THEREFORE, BE IT RESOLVED BY the Papago Council that in accordance with  
30 the provisions of Section 8 C(2) of the Plan of Operation of the  
31 Papago Farming Authority the following persons, meeting the  
32 qualifications of Section 8 B of the Plan of Operation, are appointed

1 as directors of the Management Board for the following terms:

2 One year: 1) Arthur Pacheo, Jr.

3 2) Edward Manuel

4 3) Bert Enos

5 Two years: 1) W. W. "Pat" Garrett

6 2) Tony Felix

7 3) Archie Hendricks

8 Three years: 1) Brooks Taylor

9 2) Gleason Norris

10 The foregoing Resolution was duly enacted by the Papago Council one the 5th  
11 day of November, 1980, at a meeting at which a quorum was present with a vote  
12 of 583.5 for; 356. against 25.5 not voting; and 1 absent, pursuant  
13 to the authority vested in the Papago Council by Section(e) and (f) of Article  
14 V of the Constitution and By-laws of the Papago Tribe of Arizona as amended,  
15 ratified by the Papago Tribe on December 12, 1936, and approved by the Secretary  
16 of the Interior on January 5, 1937, pursuant to Section 16 of the Act of June  
17 18, 1934 (48 Stat. 984). Said Resolution is not subject to review by the  
18 Secretary of Interior and is effective as of the date of its enactment by the  
19 Papago Council.
