

RESOLUTION OF THE PAPAGO TRIBAL COUNCIL
(Approving Federal Revenue Sharing
Budget of Sells District Council)

RES. NO. 125-80

1 WHEREAS, the Papago Council did by Resolution No. 11-80 allocate \$28,602.60 of
2 Federal Revenue Sharing Funds to the Sells District and did authorize
3 distribution of said funds upon approval of the Papago Council of the
4 District Council's request therefore based on the qualifying priorities
5 expressed at the public Revenue Sharing hearings; and

6 WHEREAS, the Sells District Council did adopt the attached Revenue Sharing
7 Funds Budget in the sum of \$28,602.60 for the district; and

8 WHEREAS, the Papago Council has reviewed and approved said budget.


9 NOW, THEREFORE, BE IT RESOLVED by the Papago Council that it does hereby
10 approve the attached Revenue Sharing funds budget, and does hereby
11 authorize distribution of the sum of \$28,602.60 to the Sells District
12 Council in accordance with the attached budget of the Sells District
13 Council.

14 The foregoing Resolution was duly enacted by the Papago Council on the 6th
15 day of November, 1980, at a meeting at which a quorum was present with a vote
16 of 965 for; 0 against; 0 not voting; and 1 absent, pursuant
17 to the authority vested in the Council by Section 2 (a) (d) and (f) and Section
18 3 (a) of Article V of the Constitution and By-laws of the Papago Tribe as
19 amended, ratified by the Papago Tribe on December 12, 1936, and approved by the
Secretary of the Interior on January 5, 1937, pursuant to Section 16 of the Act
of June 18, 1934 (48 Stat. 984). Said Resolution is not subject to review by
Secretary of Interior and is effective as of the date of it's enactment by the
Papago Council.
