

RESOLUTION OF THE PAPAGO TRIBAL COUNCIL  
(Approving San Lucy FY 81 District  
Budget)

RES. NO. 126-80

1 WHEREAS, the San Lucy District Council has by Resolution 11-80, adopted the  
2 attached FY 1981 Budget for the San Lucy District; and

3 WHEREAS, the Papago Council has reviewed said budget and has determined that  
4 San Lucy District has sufficient funds available to fund its FY 81  
5 budget.

6 NOW, THEREFORE, BE IT RESOLVED by the Papago Council that it does hereby  
7 approve the attached FY 1981 budget of the San Lucy District in the  
8 sum of \$66,918.80.

9 The foregoing Resolution was duly enacted by the Papago Council on the 6th  
10 day of November, 1980, at a meeting at which a quorum was present with a vote  
11 of 647.5 for; 159. against; 60. not voting; and 3 absent, pursuant  
12 to the authority vested in the Council by Section 2 (e) and (f) of Article V  
13 of the Constitution and By-laws of the Papago Tribe as amended, ratified by  
14 the Papago Tribe on December 12, 1936, and approved by the Secretary of the  
15 Interior on January 5, 1937, pursuant to Section 16 of the Act of June 18, 1934  
16 (48 Stat. 984). Said Resolution is not subject to review by the Secretary of  
17 Interior and is effective as of the date of it's enactment by the Papago  
18 Council.
