20 NOW, THEREFORE, BE IT RESOLVED that it is hereby determined that the above

21 named applicants are eligible for enrollment as members of the

22 Papago Tribe under Section 1 (a) or (b) of Article II of the Papago

23 constitution and By-laws, as amended, and their applications are

24 approved, as herein above indicated.

25 BE IT FURTHER RESOLVED that the Chairman and other appropriate officers of

26 the Papago Tribe reduce this final determination in writing regarding

27 each of the foregoing applications for enrollment in accordance with

28 Section 3 (c) of Article III of the Papago Tribe Enrollment Ordinance;

29 give notice of this Council's determination in accordance with Section

30 4 of Article III of the Papago Tribe Enrollment Ordinance; and place

31 the names of each applicant upon the Tribal Membership Roll in

32 accordance with Article V of the Papago Tribe Enrollment Ordinance.

1 The foregoing Resolution was duly enacted by the Papago Council on the 7th
 2 day of November, 1980, at a meeting at which a quorum was present with a vote
 3 of 965 for; 0 against; 0 not voting; and 1 absent, pursuant
 4 to the authority vested in the Papago Council by Article II and Article V,
 5 Section 2 (f) of the Constitution and By-laws of the Papago Tribe of Arizona
 6 as amended, ratified by the Papago Tribe on December 12, 1936, and approved
 7 by the Secretary of the Interior on January 6, 1937, pursuant to Section 16
 8 of the Act of June 18, 1934 (48 Stat. 984). Said Resolution is not subject
 9 to review by the Secretary of the Interior and is effective as of the date of
 10 its enactment by the Papago Council.
