7	to make payments due under said contracts and its failure to do so						
8	jeapordized the economic and financial security of the Tribal						
9	Government.						
10	NOW, THEREFORE, BE IT RESOLVED by the Papago Council that it does hereby demand						
11	that the United States make payment forthwith all funds due the						
12	Papago Tribe under contract with the Indian Health Services.						
13	The foregoing Resolution was duly enacted by the Papago Council on the 7th day of November, 1980, at a meeting at which a quorum was present with a vote						
14	of 914.5 for; 0 against; 50.5 not voting; and 1 absent, pursuant to the authority vested in the Council by Section 2 (a) and (d) of Article V						
15	of the Constitution and By-laws of the Papago Tribe as amended, ratified by the Papago Tribe on December 12, 1936, and approved by the Secretary of the						
16 17	Interior on January 5, 1937, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984). Said Resolution is not subject to review by the Secretary of
