

RESOLUTION OF THE PAPAGO TRIBAL COUNCIL
(Appointment of I.D.D.A. Representative)

RES. NO. 131-80

1 WHEREAS, the Papago Council is concerned about the amount of time and work
2 commitments required of representatives to the Indian Development
3 District of Arizona ("IDDA") and about the work load already
4 placed upon the office of Chairman of the Papago Council; and

5 WHEREAS, the Papago Tribe participated directly and substantially in IDDA's
6 funding and programs only through the Tribe's C.E.T.A. and
7 Elderly Programs.

8 NOW, THEREFORE, BE IT RESOLVED by the Papago Council that it does hereby
9 relieve its Chairman from any further responsibilities as
10 representative of the Papago Tribe to the Indian Development
11 District of Arizona, and does hereby direct and delegate authority
12 to the Chairman to appoint a person involved in the Papago Tribe's
13 Elderly or CETA Program to act as representative of the Papago
14 Tribe to the Indian Development District of Arizona.

15 The foregoing Resolution was duly enacted by the Papago Council on the 7th
16 day of November, 1980, at a meeting at which a quorum was present with a vote
17 of 965 for; 0 against; 0 not voting; and 1 absent, pursuant
18 to the authority vested in the Papago Council by Section 2 (e) and (f) of
19 Article V of the Constitution and By-laws of the Papago Tribe of Arizona as
20 amended, ratified by the Papago Tribe on December 12, 1936, and approved by
the Secretary of the Interior on January 5, 1937, pursuant to Section 16 of
the Act of June 18, 1934 (48 Stat. 984). Said Resolution is not subject to
review by the Secretary of the Interior and is effective as of the date of
it's enactment by the Papago Council.
