RESOLUTION OF THE PAPAGO TRIBAL COUNCIL (Amendment to Proposed Constitution)

RES. NO. 132-80

1 WHEREAS, the Papago Council has reviewed Section 5 of Article XVI, Land Policies of the porposed Constituiton, Revised 6/6/80, and is concerned about 2 the inflexible percentage therein set out. 3 NOW, THEREFORE, BE IT RESOLVED that Section 5 of Article XVI, Land Policies, of 5 the proposed Constitution, be amended by the Constitution Committee so 6 as to require the Papago Council annually to designate a certain 7 percentage of proceeds derived from natural resources of the Papago 8 Nation, consistent with the economic needs of the Nation, to be 9 deposited and invested for the purpose of acquiring lands, natural 10 resources, minerals and water rights within or adjacent to the Papago 11 Nation or historically a part of the Papaguria. 12 The foregoing Resolution was duly enacted by the Papago Council on the 7th day of November, 1980, at a meeting at which a quorum was present with a vote 13|bf 373 for; 159 _against;__60 not voting; and 3 absent, pursuant to the authority vested in the Council by Section 2 (e) of Article V of the 14 Constitution and By-laws of the Papago Tribe as amended, ratified by the Papago Tribe on December 12, 1936, and approved by the Secretary of the Interior on 15 January 5, 1937, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
