

RESOLUTION OF THE PAPAGO TRIBAL COUNCIL

RES. NO. 135-80

1 WHEREAS, The Papago Council has been advised by the Treasurer and Administra-  
2 tive officers of the Papago Tribe that the Papago Tribe has a serious  
3 cash flow emergency; and

4 WHEREAS, it is essential that a plan be developed to meet this emergency.

5 NOW, THEREFORE, BE IT RESOLVED by the Papago Council that the chief  
6 administrative officers of the Papago Tribe are hereby directed to  
7 call an immediate emergency meeting to develop a plan by Wednesday,  
8 November 15, 1980, to manage the Tribe's cash flow problem.

9 BE IT FURTHER RESOLVED that the Chairman and Vice Chairman of the Papago  
10 Council shall be fined \$1,000.00 for each day between November 8 and  
11 13, 1980, that they shall fail to attend such meeting.

12 The foregoing Resolution was duly enacted by the Papago Council on the 7th  
13 day of November, 1980 at a meeting at which a quorum was present with a vote  
14 of 666.5 for; 137. against; 55.5 not voting; and 7 absent,  
15 pursuant to the authority vested in the Papago Council by Section 2 (e) and (f)  
16 of Article V of the Constitution and by-laws of the Papago Tribe of Arizona as  
17 amended, ratified by the Papago Tribe on December 12, 1936, and approved by  
18 the Secretary of the Interior on January 6, 1937, pursuant to Section 16 of  
19 the Act of June 18, 1934 (48 Stat. 984). Said Resolution is not subject to  
20 review by the Secretary of the Interior and is effective as of the date of its  
21 enactment by the Papago Council.
