1 the Papago Tribe on December 12, 1936, and approved by the Secretary of the
2 Interior on January 6, 1937, pursuant to Section 16 of the Act of June 18,
3 1934 (48 Stat. 984). Said Resolution is not subject to review by the Secretary
4 of Interior and is effective as of the date of it's enactment by the Papago
5 Council.
