

RESOLUTION OF THE PAPAGO TRIBAL COUNCIL
(Authorizing Endorsement of EDA Grant)
(to Sells Shopping Center Phase II)

RES. NO. 140-80

1 WHEREAS, the Papago Council did on July 22, 1977, by Resolution No. 59-77,
2 authorize the acceptance of an EDA offer of Grant (EDA Project No.
3 07-01-01928) for the engineering and construction of the proposed
4 Papago Tribe Indian Business Opportunity Building to be located on
5 leased land within the San Xavier Industrial Park; and

6 WHEREAS, the Papago Council did on June 5, 1979, by Resolution No. 48-79,
7 approve the endorsement by the Papago Tribe of the offer of Grant
8 to the San Xavier Development Authority, a tribally chartered
9 public body formed to foster and promote the development of
10 business and employment opportunities in the San Xavier District
11 of the Papago Reservation; and

12 WHEREAS, the San Xavier Development Authority has been unable to meet the
13 conditions of the EDA offer of Grant for an Indian Business
14 Opportunity Building, and has advised the Papago Council that it
15 would be in the best interest of the Papago Tribe that the offer
16 of Grant be endorsed back to the Papago Tribe for the development
17 of Phase II of the Sells Shopping Center.

18 NOW, THEREFORE, BE IT RESOLVED by the Papago Council that it does hereby
19 accept and approve endorsement by the San Xavier Development
20 Authority of the offer of Grant of the Economic Development
21 Authority of the U. S. Department of Commerce (Project No. 07-01-
22 10928) to the Papago Tribe for the purpose of developing the
23 Sells Shopping Center, Phase II.

24 BE IT FURTHER RESOLVED by the Papago Council that it does hereby authorize
25 and direct the Chairman and other appropriate officers of the
26 Papago Council, on behalf of the Papago Tribe, to execute and file
27 any and all appropriate instruments with the U. S. Department of
28 Commerce to effectuate the purposes of this Resolution.


29 The foregoing Resolution was duly enacted by the Papago Council on the 2nd
30 day of December, 1980, at a meeting at which a quorum was present with a vote
31 of 914.5 for; 0 against; 0 not voting; and 2 absent,
32 pursuant to the authority vested in the Papago Council by Section 2 (a), (e),
(f) and (h) of Article V of the Constitution and By-laws of the Papago Tribe
of Arizona as amended, ratified by the Secretary of the Interior on January 6,
1937, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).

1 Said Resolution is not subject to review by the Secretary of the Interior
2 and is effective as of the date of its enactment by the Papago Council.
