

RESOLUTION OF THE PAPAGO TRIBAL COUNCIL
(Consent to extend Grant of Easement for
Right-of-Way ID No. 1105-11-Why 1 Tucson-
150)

RES. NO. 141-80

1 WHEREAS, the Papago Council did on April 11, 1978, by Resolution No. 18-78
2 grant in consent to a Grant of Easement for Right of Way to the
3 Arizona Department of Transportation, Highway Division, ID No. 1105-
4 11-Why 1 Tucson-150, for the purpose of photogrammetry and making a
5 mapping survey of State Route 86 from Why to Tucson, Arizona; and

6 WHEREAS, said consent was granted on condition that no land developments be
7 made and that the Papago Tribe be furnished a copy of the completed
8 survey; and

9 WHEREAS, the Arizona Department of Transportation had anticipated to complete
10 its survey by June 1980; and

11 WHEREAS, due to emergency mapping projects elsewhere necessitated by flooding
12 in 1979 and 1980 the Department could not complete the survey work
13 on the Reservation before the expiration of its anticipated completion
14 date, and has requested an extension of the Council's consent and
15 the Grant of Easement for Right of Way to June 30, 1981; and

16 WHEREAS, the proposed photogrammetry and mapping survey of State Route 86
17 will be beneficial to the Papago Tribe.

18 NOW, THEREFORE, BE IT RESOLVED by the Papago Council that it does hereby
19 consent to an extension to June 30, 1981 of the Grant of Easement
20 for Right of Way ID No. 1105-11-Why 1 Tucson-150, and of the consent
21 given to the Arizona Department of Transportation by the Papago
22 Council pursuant to the provisions of Resolution No. 18-78 for the
23 purpose of making the proposed survey of State Route 86.

24 The foregoing Resolution was duly enacted by the Papago Council on the 2nd
25 day of December, 1980, at a meeting at which a quorum was present with a vote
26 of 838.5 for; 76 against; 0 not voting; and 2 absent, pursuant
27 to the authority vested in the Papago Council by Section 2 (a), (c) and (h) of
28 Article V of the Constitution and By-laws of the Papago Tribe as amended,
29 ratified by the Papago Tribe on December 12, 1936, and approved by the Secretary
30 of the Interior on January 6, 1937, pursuant to Section 16 of the Act of June
31 18, 1934 (48 Stat. 984). Said Resolution is not subject to review by the
32 Secretary of the Interior and is effective as of the date of it's enactment
by the Papago Council.
