

RESOLUTION OF THE PAPAGO TRIBAL COUNCIL
(Supporting NCAI Declaration of War on)
(Indian Alcoholism and Drug Abuse)

RES. NO. 142-80


1 WHEREAS, alcoholism has and continues to have a detrimental impact on the
2 social, physical, psychological, economic and educational
3 condition of American Indians which was highlighted by the Task
4 Force II Report of the American Indian Policy Review Commission
5 and which was addressed at the 1980 Mid-Year Conference of the
6 National Congress of American Indians ("NCAI") by a Declaration
7 of War on Indian Alcoholism and Drug Abuse; and

8 WHEREAS, the Papago Council recognizes alcoholism and drug abuse as the
9 most devastating health problem faced by the Papago people and
10 approves the intent and purpose of the Articles of War contained
11 in said Declaration of War of the National Congress of American
12 Indians.


13 NOW, THEREFORE, BE IT RESOLVED that the Papago Council does hereby approve
14 of, and adopt the Articles of War contained in the Declaration of
15 War on Indian Alcoholism and Drug Abuse passed at the 1980 Mid-Year
16 Conference of the National Congress of American Indians, which
17 Articles of War are incorporated herein by reference.

18 The foregoing Resolution was duly enacted by the Papago Council on the 2nd
19 day of December, 1980, at a meeting at which a quorum was present with a vote
20 of 914.5 for; 0 against; 0 not voting; and 2 absent,
21 pursuant to the authority vested in the Papago Council by Section 2 (a), (d)
22 and (h) of Article V of the Constitution and By-laws of the Papago Tribe of
Arizona as amended, ratified by the Secretary of the Interior on January 6,
1937, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
Said Resolution is not subject to review by the Secretary of the Interior and
is effective as of the date of its enactment by the Papago Council.
