

RESOLUTION OF THE PAPAGO TRIBAL COUNCIL

(Central Arizona Project Indian)
(Water Delivery Contract)

RES. NO. 143-80

1 WHEREAS, the Secretary of the Interior has allocated 27,000 acre feet of
2 Central Arizona Project water to the San Xavier Reservation for
3 Tribal homeland purposes; 10,800 acre feet to the Eastern part
4 of the Schuk Toak District for Tribal homeland purposes; and
5 8,000 acre feet to the ChuiChu area of the Sif Oidak District
6 for agricultural purposes; and

7 WHEREAS, the San Xavier District Council, the Schuk Toak District Council
8 and the Sif Oidak District Council have by resolutions approved
9 the Secretary's allocation of Central Arizona project water to
10 their respective Districts and the terms and conditions connected
11 therewith, and have stated their wishes for the Papago Council to
12 pass a resolution approving the execution of a contract with the
13 United States of America for the delivery of Central Arizona
14 Project water to their respective Districts; and

15 WHEREAS, these three (3) Districts are in need of Central Arizona Project
16 water for Tribal homeland and agricultural purposes; and

17 WHEREAS, the Papago Tribal Council has reviewed a copy of the proposed
18 Central Arizona Project Indian water delivery contract between
19 the United States of America and the Papago Tribe; and

20 WHEREAS, the Papago Council believes that it is in the best interest of
21 the Papago Tribe to enter into said contract for the delivery of
22 Central Arizona Project water to the San Xavier, Schuk Toak and
23 Sif Oidak Districts.

24 NOW, THEREFORE, BE IT RESOLVED that the Papago Council does hereby approve
25 the Central Arizona Project Indian Water Delivery Contract between
26 the United States and the Papago Tribe and hereby authorizes and
27 directs Max H. Norris, Chairman, or in the Chairman's absence,
28 Enos J. Francisco, Jr., the Vice Chairman, and Ida L. Jose', the
29 Secretary of the Papago Council to execute said Contract and any
30 other documents, instruments, or amendments incidental thereto.

31 The foregoing Resolution was duly enacted by the Papago Council on the 12th
32 day of December, 1980, at a meeting at which a quorum was present with a vote
of 965. for; 0 against; 0 not voting; and 1 absent, pursuant

1 to the authority vested in the Papago Council by Section 2 (a) and (h) of
2 Article V of the Constitution and By-laws of the Papago Tribe of Arizona
3 as amended, ratified by the Papago Tribe on December 12, 1936, and approved
4 by the Secretary of the Interior on January 6, 1937, pursuant to Section 16
of the Act of June 18, 1934 (48 Stat. 984). Said Resolution is not subject
to review by the Secretary of the Interior and is effective as of the date
of its enactment by the Papago Council.
