

RESOLUTION OF THE PAPAGO TRIBAL COUNCIL
(Increasing Fees for Livestock Registration,
(Renewal, Transfer of Duplication)

RES. NO. 146-80

1 WHEREAS, by Ordinance No. 22, the Papago Council did on November 23, 1951,
2 establish a Tribal Livestock Brand Program and did, in Section IV
3 thereof, prescribe fees for registering, recording, renewing,
4 transferring and duplicating brands; and

5 WHEREAS, the Papago Council has reviewed the prescribed fees and has
6 decided that an increase in fees is justified and proper.

7 NOW, THEREFORE, BE IT RESOLVED by the Papago Council that Section IV of
8 Ordinance 22 is hereby amended on the effective date of this
9 Resolution to read as follows:

10 SECTION IV

11 All brand transactions and applications must be accompanied
12 by the correct fees. The following prescribed fees shall
13 be the established fees:

- 14 A: For Brands Registration and Recording
with the Papago Tribe - - - - - \$15.00
15 B: For Brands Renewal - - - - - 10.00
16 C: For Brands Transfer - - - - - 8.00
D: For Brands Duplicate - - - - - 8.00

17 The foregoing Resolution was duly enacted by the Papago Council on the 15th
18 day of December, 1980, at a meeting at which a quorum was present with a vote
of 659.5 for; 156.5 against; 149. not voting; and 1 absent,
19 pursuant to the authority vested in the Papago Council by Section 2 (e), (f),
(h) and Section 3 (d) and (h) of Article V of the Constitution and By-laws of
20 the Papago Tribe of Arizona as amended, ratified by the Papago Tribe on
December 12, 1936, and approved by the Secretary of the Interior on January 5,
1937, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
21 Said Resolution is effective as of the date of its approval by the Superintendent
of the Papago Agency and is subject to review by the Secretary of the Interior.
