

RESOLUTION OF THE PAPAGO TRIBE
(Water Commission)

RES. NO. 18-80

1 WHEREAS, on the 29th day of November, 1979, the Papago Council did authorize
2 the Chairman of the Papago Tribe to appoint Six (6) tribal members
3 to a Water Commission to gather information, study, hold public
4 hearings and make recommendations to the Tribal Council in regard
5 to all water litigation, water rights violations and all other
6 water problems of the Papago Tribe; and

7 WHEREAS, the Tribal Chairman, Max H. Norris, did appoint the following
8 members of the Papago Tribe as Water Commissioners:

- 9 Rosemary Lopez - Chukut Kuk District
- 10 Max Jose - San Lucy District
- 11 John Lewis - San Xavier District
- 12 John B. Narcho - San Xavier District
- 13 Priscilla Domingo - Schuk Toak District
- 14 Willard Juan - Sif Oidak District

15 and;

16 WHEREAS, the Papago Council did not consider or set the amount of per diem
17 or the amount of mileage reimbursement to be paid Commissioners;

18 NOW, THEREFORE, BE IT RESOLVED that the Papago Council does hereby ratify
19 the Chairman's appointments of the above mentioned tribal members
20 to the Water Commission and hereby set the per diem to be paid
21 each Commissioner at \$50.00 for each day or portion of each day
22 spent at regularly called Water Commission meetings plus reimburse-
23 ment of 20¢ per mile for Commissioner vehicles used for Water
24 Commission purposes.

25 BE IT FURTHER RESOLVED that all per diem and mileage reimbursement be paid
26 retroactive for all Commission meetings held since December 27, 1979.

27 The foregoing Resolution was duly enacted by the Papago Council on the 7th
28 day of March, 1980, at a meeting at which a quorum was present with a vote
29 of 965 for; 0 against; 0 not voting; and 1 absent, pursuant
30 to the authority vested in the Council by Section 2 (e), (f) and (m) of
31 Article V of the Constitution and By-Laws of the Papago Tribe as amended,
32 ratified by the Papago Tribe on December 12, 1936 and approved by the Secretary
of the Interior on January 6, 1937, pursuant to Section 16 of the Act of June
18, 1934 (48 Stat. 984). Said Resolution is not subject to review by the
Secretary of Interior and is effective as of the date of its enactment by the
Papago Council.
