

RESOLUTION OF THE PAPAGO TRIBAL COUNCIL

Resolution No. 26-80

1 WHEREAS, Section 2 of Chapter I of the Law and Order Code provides for the
 2 appointment of Judges of the Papago Tribal Courts by the Commissioner
 3 of Indian Affairs, subject to confirmation by a majority vote of the
 4 Papago Council; and
 5 WHEREAS, such appointment is for a maximum term of two years; and
 6 WHEREAS, it is the recommendation of the Papago Council that Henry Manuel be
 7 appointed as Judge for a two year term,
 8 NOW, THEREFORE, BE IT RESOLVED by the Papago Council that it does hereby
 9 recommend to the Commissioner of Indian Affairs the appointment of
 10 Henry Manuel, and does confirm such appointment as Full Time Judge
 11 of the Papago Tribal Court.

 13 The foregoing resolution was duly enacted by the Papago Council on the 9th
 14 day of April, 1980, at a meeting at which a quorum was present (see attached
 15 voting record), pursuant to the authority vested in the Papago Council by
 16 Section 2 (e) and (f) of Article V of the Constitution and By-Laws of the
 17 Papago Tribe as amended, ratified by the Papago Tribe on December 12, 1936,
 and approved by the Secretary of the Interior on January 6, 1937, pursuant to
 Section 16 of the Act of June 18, 1934 (48 Stat, 984). Said Resolution is not
 subject to review by the Secretary of Interior and is effective as of the date
 of its enactment by the Papago Council.
