

RESOLUTION OF THE PAPAGO TRIBAL COUNCIL

Resolution No. 36-80

1 WHEREAS, the Papago Council has reviewed the recommendations of the Papago  
2 Enrollment Committee in accordance with Section 3 (a) and 3 (c) of  
3 Article III of the Papago Tribal Enrollment Ordinance, Ordinance No.  
4 49, and has made a final determination that the applications of the

1 NOW, THEREFORE, BE IT RESOLVED that it is hereby determined that the above  
2 named applicants are eligible for enrollment as members of the Papago  
3 Tribe under Section 1 (a) or (b) of Article II of the Papago  
4 Constitution and By-Laws, as amended, and that their applications are  
5 approved, as herein above indicated.

6 BE IT FURTHER RESOLVED that the Chairman and other appropriate officers of the  
7 Papago Tribe reduce this final determination to writing regarding  
8 each of the foregoing applications for enrollment in accordance with  
9 Section 3 (c) of Article III of the Papago Tribe Enrollment Ordinance;  
10 give notice of this Council's determination in accordance with Section  
11 4 of Article III of the Papago Tribe Enrollment Ordinance; and place  
12 the names of each applicant upon the Tribal membership roll in  
13 accordance with Article V of the Papago Tribe Enrollment Ordinance.

14 The foregoing Resolution was duly enacted by the Papago Council on the 9th.  
15 day of May, 1980, at a meeting at which a quorum was present with a vote of  
16 965 for; 0 against; 0 not voting; and 0 absent, pursuant to  
17 authority vested in the Papago Council by Article II and Article V, Section 1  
18 (f) of the Constitution and By-Laws of the Papago Tribe of Arizona, ratified  
19 by the Tribe on December 12, 1936, and approved by the Secretary of the  
20 Interior on January 6, 1937, pursuant to Section 16 of the Act of June 18, 1934  
21 (48 Stat. 984). Said Resolution is not subject to review by the Secretary of  
22 the Interior and is effective as of the date of its enactment by the Papago  
23 Council.
