

RESOLUTION OF THE PAPAGO COUNCIL
(Appointing Papago Tribal Utility Authority Directors)

RES. NO. 40-80

1 WHEREAS, the terms of Lester Ormsby and Harold T. Johnson as members of the
2 Board of Directors of the Papago Tribal Utility Authority expires on
3 June 30, 1980; and

4 WHEREAS, both Lester Ormsby and Harold T. Johnson meet the qualifications of
5 Section 8 of the Plan of Operation of the Authority, have been
6 valuable and contributing members of the Board, have been recommended
7 for re-appointment to the Board, and have indicated their willingness
8 to continue as members of the Board of the Authority.

9 NOW, THEREFORE, BE IT RESOLVED by the Papago Council that it does hereby
10 re-appoint Lester Ormsby and Harold T. Johnson as members of the Board
11 of Directors of the Papago Tribal Utility Authority for terms of
12 three (3) years starting June 30, 1980.

13 The foregoing Resolution was duly enacted by the Papago Council on the 3rd
14 day of June, 1980, at a meeting at which a quorum was present with a vote of
15 615.5 for; 194.5 against; 155 not voting; and 0 absent, pursuant
16 to the authority vested in the Council by Section 2 (e) of Article V of the
17 Constitution and By-laws of the Papago Tribe as amended, ratified by the
18 Papago Tribe on December 12, 1936, and approved by the Secretary of the Interior
19 on January 6, 1937, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.
20 984). Said Resolution is not subject to review by the Secretary of the Interior
21 and is effective as of the date of its enactment by the Papago Council.
