

RESOLUTION OF THE PAPAGO COUNCIL
(Gu Achi District Budget)

Resolution No. 52-80

1 WHEREAS, the Gu Achi District Council proposed its budget in the amount of
2 Twenty three thousand three hundred twenty dollars (\$23,320.00) for
3 the fiscal year 1980-81 out of the Gu Achi District account; and
4 WHEREAS, the money to be used to pay for the telephone, electricity, maintenance
5 and supplies, emergencies, travel and District Secretary/Treasurer
6 salary and fringe benefits for the operation of the Gu Achi District
7 Office; and
8 WHEREAS, one thousand four hundred dollars (\$1400) be used to purchase
9 removeable personal property on an invalid mining claim (Crown Jewel
10 claim); and
11 WHEREAS, three thousand (\$3000) be set aside to be used for miscellaneous.

12 NOW, THEREFORE, BE IT RESOLVED by the Papago Council that it does hereby
13 approve the Gu Achi District budget as follow:

the Act of June 18, 1934 (48 Stat. 984). Said Resolution is effective as of
the date of its approval by the Superintendent of the Papago Agency and is
subject ot review by the Secretary of the Interior.
