

RESOLUTION OF THE PAPAGO COUNCIL
(Appointment of two (2))
(Housing Commissioners)

RES. NO. 54-80

1 WHEREAS, the term of office of Malinda Manuel on the Board of Commissioners
2 of the Papago Housing Authority has expired; and

3 WHEREAS, Francisco Jose', Jr., has resigned from the Board of Commissioners
4 of the Papago Housing Authority; and

5 WHEREAS, it is necessary that two replacement Commissioners be appointed to
6 the Board of Commissioners of the Papago Housing Authority.

7 NOW, THEREFORE, BE IT RESOLVED by the Papago Council that Alex Juan and
8 Cipriano Manuel are hereby appointed members of the Board of
9 Commissioners of the Papago Housing Authority in place,
10 respectively, of Malinda Manuel and Francisco Jose', Jr.

11 The foregoing Resolution was duly enacted by the Papago Council on the 20th
12 day of June, 1980, at a meeting at which a quorum was present with a vote of
13 935 for; 0 against; 0 not voting; and 2 absent pursuant to
14 the authority vested in the Papago Council by Section 2 (e) and (f) of Article
15 V of the Constitution and By-laws of the Papago Tribe of Arizona, as amended,
16 ratified by the Papago Tribe on December 12, 1936, and approved by the
17 Secretary of the Interior on January 6, 1937, pursuant to Section 16 of the Act
18 of June 18, 1934 (48 Stat. 984). Said Resolution is not subject to review by
19 the Secretary of the Interior and is effective as of the date of its enactment
20 by the Papago Council.
