

RESOLUTION OF THE PAPAGO COUNCIL
Plan of Operation for O'odham Construction
& Materials Co.

RES. NO. 58-80

1 WHEREAS, the Papago Tribe is presently operating Papago Construction as a
2 department of the Papago Tribe pursuant to Papago Council Resolution
3 No. 9-73 under a Plan of Operating emphasizing employment training for
4 Papago people; and

5 WHEREAS, by Resolution No. 102-79, the Papago Council directed that Papago
6 Construction be reorganized under a Plan of Operation which will assure
7 that, consistent with good business ethics, it will make a profit for
8 the benefit of the Papago Tribe.

9 NOW, THEREFORE BE IT RESOLVED by the Papago Council that the O'odham Construction
10 & Materials Co. is hereby created under the attached Plan of Operation.

11 The foregoing Resolution was duly enacted by the Papago Council on the 8th.
12 day of July, 1980, at a meeting at which a quorum was present with a vote of
13 905 for; 0 against; 60 not voting; and 1 absent pursuant
14 to the authority vested in the Papago Council by Section 2 (e) and (f) and
15 Section 3 (a) and (h) of Article V of the Papago Constitution and By-Laws of
16 the Papago Tribe of Arizona, as amended, ratified by the Papago Tribe on Dec-
17 ember 12, 1936, and approved by the Secretary of the Interior on January 6,
18 1937, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984). Said
19 Resolution is subject to review by the Secretary of the Interior and is effective
20 as of the date of its enactment by the Papago Council.
