

RESOLUTION OF THE PAPAGO COUNCIL
(Approving Federal Revenue Sharing Budget)
(of San Xavier District Council)

RES. NO. 73-80

1 WHEREAS, the Papago Council did by Resolution No. 11-80, allocate \$17,203.85
2 of Federal Revenue Sharing Funds to the San Xavier District and
3 did authorize distribution of said funds to the District upon
4 approval by the Council of the District's request therefore based
5 on the qualifying priorities expressed at the Revenue Sharing
6 Public Hearings; and

7 WHEREAS, the San Xavier District Council did by Resolution No. 6-1-80,
8 adopt a Revenue Sharing budget in the amount of \$17,201.75 for
9 the District; and

10 WHEREAS, the Papago Council has reviewed and approved said budget.


11 NOW, THEREFORE, BE IT RESOLVED by the Papago Council that it does hereby
12 approve the attached Federal Revenue Sharing budget and does
13 hereby authorize distribution of the sum of \$17,201.75 to the
14 San Xavier District Council.

15 The foregoing Resolution was duly enacted by the Papago Council on the 4th
16 day of August, 1980, at a meeting at which a quorum was present with a vote
17 of 965 for; 0 against; 0 not voting; and 3 absent,
18 pursuant to the authority vested in the Council by Section 2 (f) and Section
19 3 (a) and (h) of Article V of the Constitution and By-laws of the Papago
20 Tribe as amended, ratified by the Papago Tribe on December 12, 1936, and
approved by the Secretary of the Interior on January 6, 1937, pursuant to
Section 16 of the Act of June 18, 1934 (48 Stat. 984). Said Resolution is
effective as of the date of its approval by the Superintendent of the Papago
Agency and is subject to review by the Secretary of the Interior.
