15 NOW, THEREFORE, BE IT RESOLVED that it is hereby determined that the above
16 named applicants are eligible for enrollment as members of the
17 Papago Tribe under Section 1 (a) or (b) of Article II of the
18 Papago Constitution and By-laws, as amended, and that their appli-
19 cations are approved, as herein above indicated.

20 BE IT FURTHER RESOLVED that the Chairman and other appropriate officers of
21 the Papago Tribe reduce this final determination to writing
22 regarding each of the foregoing applications for enrollment in
23 accordance with Section 3 (c) of Article III of the Papago Tribe
24 Enrollment Ordinance; give notice of this Council's determination
25 in accordance with Section 4 of Article III of the Papago Tribe
26 Enrollment Ordinance; and place the names of each applicant upon
27 the Tribal membership roll in accordance with Article V of the
28 Papago Tribe Enrollment Ordinance.

1 The foregoing Resolution was duly enacted by the Papago Council on the 8th
2 day of August, 1980, at a meeting at which a quorum was present with a vote
3 of 864. for; 0 against; 0 not voting; and 101 absent
4 pursuant to the authority vested in the Papago Council by Article II and
5 Article V, Section 1 (f) of the Constitution and By-laws of the Papago Tribe
6 of Arizona, as amended, ratified by the Papago Tribe on December 12, 1936,
7 and approved by the Secretary of the Interior on January 6, 1937, pursuant
8 to Section 16 of the Act of June 18, 1934 (48 Stat. 984). Said Resolution
9 is not subject to review by the Secretary of the Interior and is effective
10 as of the date of its enactment by the Papago Council.
