

RESOLUTION OF THE PAPAGO TRIBAL COUNCIL
(Authorizing Acquisition of Additional Lands)
(for Florence Village)

RES. NO. 79-80

1 WHEREAS, Congress, in 1978, did by Public Law 95-361 create and establish
2 Florence Village as part of the Papago Indian Reservation; and
3 WHEREAS, the lands encompassing Florence Village, and consisting of twenty
4 acres, have already been fully assigned; and
5 WHEREAS, the members of the Papago Tribe traditionally residing in the
6 vicinity of Florence require additional land to establish their
7 homes and community; and
8 WHEREAS, the State of Arizona owns some land adjoining Florence Village
9 which may be available for expansion of the community; and
10 WHEREAS, the residents of Florence Village and the Gu Achi District Council
11 have requested assistance and funding from the Papago Council to
12 acquire the State lands adjoining Florence Village and to have
13 said lands transferred in trust to the United States of America
14 for the Papago Indian Tribe, or part of the Papago Indian
15 Reservation; and
16 WHEREAS, the Papago Council has reviewed and supports the request of the
17 residents of Florence Village and of the Gu Achi District Council.
18 NOW, THEREFORE, BE IT RESOLVED by the Papago Council that it does hereby
19 authorize and direct the Chairman, Vice Chairman, Secretary of
20 other appropriate officers of the Papago Council, the attorneys
21 of the Papago Tribe, and Angelo Joaquin, Sr., Representative of
22 the Gu Achi District to the Papago Tribal Council, to initiate
23 transactions or proceedings necessary to acquire the State lands
24 adjoining Florence Village, and to execute for or on behalf of
25 the Papago Tribe any applications or documents necessary to
26 initiate the acquisition of such lands.
27 BE IT FURTHER RESOLVED that, upon a determination of the appraisal or
28 purchase price for such lands, a report be made thereof to the
29 Papago Council for further action.

1 The foregoing Resolution was duly enacted by the Papago Council on the 11th
2 day of August, 1980, at a meeting at which a quorum was present with a vote
3 of 632, for; 0 against; 265, not voting; and 68 absent
4 pursuant to the authority vested in the Papago Council by Section 2 (a) and
5 (e) of Article V of the Constitution and By-laws of the Papago Tribe of
6 Arizona, as amended, ratified by the Papago Tribe on December 12, 1936, and
7 approved by the Secretary of the Interior on January 6, 1937, pursuant to
8 Section 16 of the Act of June 18, 1934 (48 Stat. 984). Said Resolution is
9 not subject to review by the Secretary of the Interior and is effective as
10 of the date of its enactment by the Papago Council.
