

RESOLUTION OF THE PAPAGO TRIBAL COUNCIL

(Appointment of Rodeo Committee)

RES. NO. 82-80

1 WHEREAS, the Papago Council has failed to appoint a Board of Directors of
2 the Papago Fair and Rodeo Association in time to organize and
3 manage the 1980 Papago Fair, Livestock Show and Rodeo; and

4 WHEREAS, the Budget and Finance Committee has recommended that a temporary
5 five member Rodeo Committee, consisting of;

7 2. Wesley Jose
8 3. Nathan Pablo
9 4. Allen Throssell
10 5. Mark Lopez

11 be appointed to organize and manage the 1980 Annual Papago Fair,
12 Livestock Show and Rodeo with a budget of \$18,217.00, and that
13 the Committee have the part time services of a secretary to be
14 assigned to it by Tribal Administration; and

15 WHEREAS, the Papago Council concurs in the recommendation of the Budget
16 and Finance Committee.

17 NOW, THEREFORE, BE IT RESOLVED by the Papago Council that it does hereby
18 appoint a Rodeo Committee, consisting of the following five
19 members of the Papago Tribe, to wit:

- 20 1. Silas Hendricks
21 2. Wesley Jose
22 3. Nathan Pablo
23 4. Allen Throssell
24 5. Mark Lopez

25 to organize, manage and operate the 1980 Annual Papago Fair,
26 Livestock Show and Rodeo with a budget of \$18,217.00.

27 BE IT FURTHER RESOLVED that the Rodeo Committee shall receive the part
28 time services of a Secretary to be assigned to it by Tribal
29 Administration, and that the Committee account to the Treasurer
30 of the Papago Council for its receipts and disbursements in
31 accordance with procedures to be established by the Treasurer.

32 The foregoing Resolution was duly enacted by the Papago Council on the 8th
day of September, 1980, at a meeting at which a quorum was present with a
vote of 869.0 for; 0 against; 0 not voting; and 3 absent
pursuant to the authority vested in the Papago Council by Section 2 (e) and
(f) and Section 3 (a) and (h) of Article V of the Constitution and By-laws of
the Papago Tribe of Arizona, as amended, ratified by the Papago Tribe on
December 12, 1936, and approved by the Secretary of the Interior on January 6,
1937, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984). Said
Resolution is subject to review by the Secretary of the Interior and is
effective as of the date of enactment by the Papago Council.
