2 to the Papago Council from the San Lucy District; and


3 WHEREAS, the Papago Council has reviewed his request and accepts his resignation

6 NOW, THEREFORE, BE IT RESOLVED by the Papago Council that it does hereby accept
7 the resignation of Ricardo M. Baptisto as representative to the Papago
8 Council from the San Lucy District.


9 BE IT FURTHER RESOLVED by the Papago Council that it does hereby thank and
10 commend Ricardo M. Baptisto for his work and faithful services on
11 behalf of the people of the San Lucy District and of the Papago Tribe
12 as a whole.

13 The foregoing Resolution was duly enacted by the Papago Council on the 8th.
14 day of September, 1980, at a meeting at which a quorum was presented with a vote
15 of 869.0 for; 0 against; 0 not voting; 3 absent; pursuant to
16 the authority vested in the Council by Section 2 (f) of Article V of the
17 Constitution and By-Laws of the Papago Tribe as amended ratified by the Papago
18 Tribe on December 12, 1936, and approved by the Secretary of the Interior on
19 January 6, 1937, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.
20 984). Said Resolution is effective as of the date of its approval by the
21 Superintendent of the Interior.


