

RESOLUTION ON THE PAPAGO COUNCIL  
(Ratifying Execution of CETA )  
(Intergovernmental Agreement(s))

RES. NO. 85-80

1 WHEREAS, the Papago Council did on February 3, 1978, by Resolution No. 3-78,  
2 authorize the entering into Intergovernmental Agreement(s) between  
3 the Papago Tribe and the Maricopa County Board of Supervisors  
4 providing for public service employment for members of the Papago  
5 Tribe residing in the San Lucy (Gila Bend) District, pursuant to  
6 the Comprehensive Employment and Training Act of 1973, as amended;  
7 and

8 WHEREAS, said Resolution No. 3-78, authorized the Chairman of the Papago Tribe  
9 to execute such Agreement(s) on behalf of the Papago Tribe; and

10 WHEREAS, the Papago Council does hereby wish to confirm the execution of such  
11 Agreement(s) on behalf of the Papago Tribe.

12 NOW, THEREFORE, BE IT RESOLVED by the Papago Council that it does hereby ratify  
13 and confirm the act of Max H. Norris, Chairman of the Papago Tribe,  
14 in entering into and executing Intergovernmental Agreement(s)  
15 providing for public service employment for members of the Papago  
16 Tribe residing in the San Lucy (Gila Bend) District, pursuant to the  
17 Comprehensive Employment and Training Act of 1973, as amended, with  
18 the Maricopa County Board of Supervisors on behalf of the Papago Tribe.

19 The foregoing Resolution was duly enacted by the Papago Council on the 9th  
20 day of September, 1980, at a meeting at which a quorum was present with a vote  
21 of 839.0 for; 0 against; 30. not voting; and 5 absent pursuant  
22 to the authority vested in the Papago Council by Section 2 (a) and (h) of  
23 Article V of the Constitution and By-laws of the Papago Tribe of Arizona, as  
24 amended, ratified by the Papago Tribe on December 12, 1936, and approved by  
the Secretary of the Interior on January 6, 1937, pursuant to Section 16 of  
the Act of June 18, 1934 (48 Stat. 984). Said Resolution is not subject to  
review by the Secretary of the Interior and is effective as of the date of  
its enactment by the Papago Council.

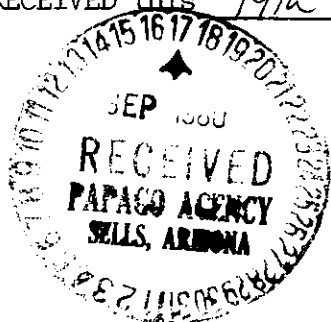
