

RESOLUTION OF THE PAPAGO TRIBAL COUNCIL
(Approving and Adopting FY 81 Tribal Budget)

RES. NO. 86-80

1 WHEREAS, the Budget and Finance Committee has reviewed the budget requests of
2 the various departments of the Papago Tribal Government, and the
3 financial reserves and anticipated income available to the Papago
4 Tribe for FY 1981, commencing October 1, 1980 and ending September
5 30, 1981; and

6 WHEREAS, the Budget and Finance Committee has reported to the Papago Council
7 that there is available to the Papago Tribe in B.I.A. IIM Accounts
8 PT-104 and PT-106 a sum in excess of \$186,000.00 and that the
9 anticipated income to the Papago Tribe in FY 1981 in the sum of
10 \$2,501,000.00; and

11 WHEREAS, the Budget and Finance Committee has recommended Departmental Budgets
12 totalling \$2,641,892.00 as the FY 1981 budget of the Papago Tribe; and

13 WHEREAS, the Papago Council has reviewed the budget requests of the various
14 departments, the recommendations of the Budget and Finance Committee,
15 and the financial reserves and anticipated income available to the
16 Papago Tribe for FY 1981.

17 NOW, THEREFORE, BE IT RESOLVED by the Papago Council that it does hereby
18 approve and adopt the attached Departmental Budgets totalling
19 \$2,641,892.00 on the FY 1981 budget of the Papago Tribe.

20 BE IT FURTHER RESOLVED that the Treasurer of the Papago Tribe is hereby
21 authorized and directed to draw upon B.I.A. IIM Accounts PT-104 and
22 PT-106 a sum not to exceed \$140,892.00 in order to pay expenses
23 authorized under the Papago Tribe's FY 1981 budget.

24 The foregoing Resolution was duly enacted by the Papago Council on the 9th
25 day of September, 1980, at a meeting at which a quorum was present with a vote
26 of 712.5 for; 126.5 against; 126. not voting; and 2 absent, pursuant
27 to the authority vested in the Papago Council by Section 2 (f) and (h) and
28 Section 3 (a) and (h) of Article V of the Constitution and By-laws of the
29 Papago Tribe of Arizona as amended, ratified by the Papago Tribe on December
30 12, 1936, and approved by the Secretary of the Interior on January 6, 1937,
31 pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984). Said
32 Resolution is subject to review by the Secretary of the Interior, and is
effective as of the date of its approval by the Superintendent of the Papago
Agency.
