1 NOW, THEREFOE, BE IT RESOLVED that it is hereby determined that the above
2 named applicants are eligible for enrollment as members of the
3 Papago Tribe under Section 1 (a) or (b) of Article II of the Papago
4 Constitution and By-Laws, as amended, and the their applications are
5 approved, as herein above indicated.

7 BE IT FURTHER RESOLVED that the Chairman and other appropriate officers of the
8 Papago Tribe reduce this final determination to writing regarding
9 each of the foregoing applications for enrollment in accordance with
10 Section 3 (c) of Article III of the Papago Tribe Enrollment
11 Ordinance; give notice of this Council's determination in accordance
12 with Section 4 of Article III of the Papago Tribe Enrollment
13 Ordinance; and place the names of each applicant upon the Tribal
14 membership roll in accordance with Article V of the Papago Tribe
15 Enrollment Ordinance.

16 The foregoing Resolution was duly enacted by the Papago Council on the 12th.
17 day of September, 1980, at a meeting at which a quorum was present with a vote
18 of 965 for; 0 against; 0 not voting; and 0 absent,
19 pursuant to authority vested in the Papago Council by Article II and Article
20 V, Section 2 (f) of the Constitution and By-Laws of the Papago Tribe of
21 Arizona, ratified by the Tribe on December 12, 1936, and approved by the
22 Secretary of the Interior on January 6, 1937, pursuant to Section 16 of the
23 Act of June 18, 1934 (48 Stat. 984). Said Resolution is not subject to review
24 by the Secretary of the Interior and is effective as of the date of its
25 enactment by the Papago Council.
