

5 NOW, THEREFORE, BE IT RESOLVED that it is hereby determined that the above  
6 named applicants are eligible for enrollment as members of the  
7 Papago Tribe under Section 1 (a) or (b) of Article II of the  
8 Papago Constitution and By-Laws, as amended, and their applications  
9 are approved, as herein above indicated.


10 BE IT FURTHER RESOLVED that the Chairman and other appropriate officers of  
11 the Papago Tribe reduce this final determination in writing  
12 regarding each of the foregoing applications for enrollment in  
13 accordance with Section 1 (C) of Article VIII of the Papago  
14 Enrollment Ordinance; give notice of this Council's determination  
15 in accordance with Section 2 (A) and (B) of Article VIII of the  
16 Papago Enrollment Ordinance; and place the names of each applicant  
17 upon the Tribal Membership Roll in accordance with Article IX of  
18 the Papago Enrollment Ordinance.

19 The foregoing Resolution was duly enacted by the Papago Council on the 8th  
20 day of January, 1982 at a meeting at which a quorum was present with a vote of  
21 1148. for; 0 against; 0 not voting; and 0 absent, pursuant to  
22 the authority vested in the Papago Council by Article II and Article V, Section  
23 2 (f) of the Constitution and By-Laws of the Papago Tribe of Arizona as amended,  
24 ratified by the Papago Tribe on December 12, 1936, and approved by the Secretary  
25 of the Interior on January 6, 1937, pursuant to Section 16 of the Act of June 18,  
26 1934 (48 Stat. 984). Said Resolution is not subject to review by the Secretary  
27 of the Interior and is effective as of the date of its enactment by the Papago  
28 Council.
