

RESOLUTION OF THE PAPAGO TRIBAL COUNCIL
(Transferring Mobile Clinic to San Lucy District)

RES. NO. 02-82

1 WHEREAS, the Papago Tribe owns a house trailer presently located at San
2 Lucy and used as a mobile clinic; and


3 WHEREAS, the trailer has been damaged by a storm and later repaired, and
4 is not used any more as a clinic; and

5 WHEREAS, the San Lucy District Council has requested transfer of the
6 trailer for use and occupancy by the District.


7 NOW, THEREFORE, BE IT RESOLVED by the Papago Council that title to the house
8 trailer used as a mobile clinic and presently located at San Lucy
9 remain in the Papago Tribe of Arizona, but that the use, possession
10 and right to occupancy of the trailer is hereby transferred to
11 the San Lucy District, and that the District henceforth shall be
12 responsible for all expenses of maintenance, insurance and repairs
13 of the trailer, and of all utilities incurred in connection there-
14 with.

15 The foregoing Resolution was duly enacted by the Papago Council on the 8th
16 day of January, 19 82, at a meeting at which a quorum was present with
17 a vote of 1148. for; 0 against; 0 not voting; and 0 absent,
18 pursuant to the authority vested in the Council by Section 2(a) and (h) and
19 3(h) of Article V of the Constitution and By-Laws of the Papago Tribe as
20 amended, ratified by the Papago Tribe on December 12, 1936, and approved by
the Secretary of the Interior on January 6, 1937, pursuant to Section 16 of
the Act of June 18, 1934 (48 Stat. 984). Said Resolution is not subject to
review by the Secretary of Interior and is effective as of the date of its
enactment by the Papago Council.
