1 WHEREAS, Congressional appropriations hearings will soon be sheeduled for 2 FY 1983 appropriations and it is necessary for the Papago Council 3 that a Committee of two Council members be established to collect 4 information and recommend and give testimony before Congress con-5 cerning the Tribe's appropriations needs and priorities. 6 NOW, THEREFORE, BE IT RESOLVED that the Papago Council does hereby establish 7 a Committee of two Council members to collect information and 8 recommend and give testimony before Congress concerning the Tribe's 9 appropriations needs and priorities. 10 The foregoing Resolution was duly enacted by the Papago Council on the 11th day of January, 1982, at a meeting at which a quorum was present with a vote of 1107. for; 41. against; 0 not voting; and 3 absent, pursuance to the authority vested in the Papago Council by Section 2 (d), (3) 11 12 and (f) of Article V of the Constitution and By-Laws of the Papago Tribe of Arizona as amended, ratified by the Papago Tribe on December 12, 1936, and 13 approved by the Secretary of the Interior on January 6, 1937, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
