1	WHEREAS, the residents of Papago-Florence Village are desirous of receiving						
2	telephone services to their homes; and						
3	WHEREAS, the Mountain Bell Company is interested in expanding its service						
4	to serve residents of the Village; and						
5	WHEREAS, the Gu Achi District Council did pass a resolution dated July 28,						
6	1982, approving the grant of easements for such purposes and						
7	suggesting that waivers of compensation be granted since the						
8	telephone service will more than off-set any monetary consideration.						
9	NOW, THEREFORE, BE IT RESOLVED by the Papago Council that it does hereby						
10	consent to grants of easement to Mountain Bell, its successors and						
11	assigns for rights-of-way for the installation, repair, maintenance,						
12	replacement and removal of telephone cables and improvements on,						
13	over, across, in and upon the Tribal lands of Florence Village for						
14	service to and as requested by residents of the Village.						
15	BE IT FURTHER RESOLVED that such easements be for periods of fifty (50) years						
16	that compensation for grants thereof be waived; and that such						
17	easements, and any interest therein, be subject to transfer by						
18	assignment, grant or otherwise.						
19	BE IT FURTHER RESOLVED that the foregoing consent to grants of easement to						
20	service residents of Florence Village shall be a continuing one						
21	and shall be in full force and effect until revoked by the Papago						
22	Council.
