9	authorized to negotiate and sign, on behalf of the Papago Tribe,							
10	a contract with the Bureau of Indian Affairs to provide ground							
11	maintenance, janitorial services, and refuse disposal for the							
12	Santa Rosa Boarding School and the San Simon School.							
13	The foregoing Resolution was duly enacted by the Papago Council on the <u>9th</u> day of September, 1982, at a meeting at which a quorum was present with a vote							
14	of <u>1121.0</u> for; <u>0</u> against; <u>27.0</u> not voting; and <u>0</u> absent, pursuant to the authority vested in the Papago Council by Section 2 (a) and (d) of Article V of the Constitution and By-laws of the Papago Tribe of Arizona as amended, ratified by the Papago Tribe on December 12, 1936, and approved
