

RESOLUTION OF THE PAPAGO TRIBAL COUNCIL  
San Xavier District Budget FY 1983

RES. NO. 111-82

- 1 WHEREAS, the San Xavier District Council did by Resolution No. 8-82-6,  
2 approve the FY 1983 budget of \$180,215.00; and  
3 WHEREAS, the San Xavier District does have a balance in excess of \$291,000.00  
4 as of June 25, 1982, in its IIM Account; and  
5 WHEREAS, the San Xavier District Council is requesting that the amount of  
6 \$180,215.00 be transferred from its IIM Account to the First  
7 Interstate Bank of Arizona, N.A., Main Office, Tucson, Arizona, due  
8 to the expense of distance traveled to and from the Sells Tribal  
9 Complex; and  
10 WHEREAS, the Papago Council has reviewed and is in agreement with the  
11 attached FY 1983 budget of the San Xavier District.  
12 NOW, THEREFORE, BE IT RESOLVED that the Papago Council does hereby approve  
13 the attached FY 1983 budget of the San Xavier District in the  
14 amount of \$180,215.00.  
15 BE IT FURTHER RESOLVED that the Papago Council does hereby grant approval  
16 for transfer of \$180,215.00 from the San Xavier District IIM Account  
17 to a separate checking and/or savings account with the First Inter-  
18 state Bank of N.A., Main Office, Tucson, Arizona, doe to the expense  
19 of distance traveled to and from the Sells Tribal Complex, and that  
20 the transfer be made on September 24, 1982, with the expenditures  
21 beginning on October 1, 1982, and ending on September 30, 1983,  
22 provided that any withdrawals from such accounts shall only be upon  
23 signature of any two of the following officers of the District  
24 Council, John B. Narcho, John Lewis, Sr., Linda Liston or Agnes  
25 McCabe, respectively the Chairman/Business Manager, Vice Chairman,  
26 Secretary and Treasurer.  
27 BE IT FURTHER RESOLVED that the San Xavier District Office shall submit to  
28 the Treasurer of the Papago Tribe a copy of monthly expenditures  
29 and balance statements to ensure that the monies budgeted in  
30 FY 1983 are being utilized in the prescribed manner.  
31 The foregoing Resolution was duly enacted by the Papago Council on the 9th  
32 day of September, 1982, at a meeting at which a quorum was present with a vote  
of 1148 for; 0 against; 0 not voting; and 1 absent,  
pursuant to the authority vested in the Papago Council by Section 3 (a) of

1 Article V of the Constitution and By-laws of the Papago Tribe of Arizona as  
2 amended, ratified by the Papago Tribe on December 12, 1936, and approved by  
3 the Secretary of the Interior on January 6, 1937, pursuant to Section 16 of  
4 the Act of June 18, 1934 (48 Stat. 984). Said Resolution is effective as  
5 of the date of its approval by the Superintendent of the Papago Agency and  
6 is subject to review by the Secretary of the Interior.
