

RESOLUTION OF THE PAPAGO TRIBAL COUNCIL
(Request to extend contract P.L. 93-638)
(with Indian Health Service)
(consolidation of lapsed 1982 CHR Funds)

1 WHEREAS, the Papago Tribe of Arizona is presently operating the following
2 programs under FY 1982 P.L. 93-638 service contracts with the
3 Public Health, Indian Health Service:

4 Coordination of Health Service
5 Papago Community Health Representative
6 Papago Alcoholism and Prevention
7 Papago Psychological Service
8 Papago Disease Control Program
9 Papago Nutrition Improvement Program

10 WHEREAS, such Tribal operations have been successful and beneficial to
11 the Papago Tribe and its people; and

12 WHEREAS, 25 CFR Sec. 371.20 of the Federal Regulations require that all
13 proposals to recontract under P.L. 93-638 be submitted to the
14 Tribal Council for approval at least 120 days prior to the contract
15 termination; and

16 WHEREAS, the Papago Tribal Council does desire to recontract for provision
17 of these services during FY 1983.

18 NOW, THEREFORE, BE IT RESOLVED by the Papago Tribal Council that it does
19 authorize and request the Public Health, Indian Health Service
20 to extend contracts utilizing lapsed 82 CHR funds with the
21 Papago Tribe under P.L. 93-638 regulations and procedures for
22 the provision of services titled:

Contract No. 249-79-0013 Papago Community Health Representatives

23 BE IT FURTHER RESOLVED that the duration of this extension shall be from
24 October 01, 1982 through September 30, 1983 or until an FY 83
25 contract becomes effective.

26 BE IT FURTHER RESOLVED that the Papago Tribe will not fund or operate
27 programs for which contracts are requested herewith which have
28 not been negotiated and executed by the Indian Health Service
29 prior to the start of the funding year.

30 BE IT FURTHER RESOLVED that Mr. Max H. Norris, Chairman or in his absence,
31 Mr. Enos J. Francisco, Jr., Vice Chairman, or Ms. Rosita Ruiz,
32 Treasurer, is hereby authorized to negotiate and execute these
contracts and any amendments thereto for the duration of the
contracts.

The foregoing Resolution was duly enacted by the Papago Council on the 13th
day of September, 1982, at a meeting at which a quorum was present with a
vote of 1148.0 for; 0 against; 0 not voting; 4 absent;
pursuant to the authority vested in the Papago Council by Section 2 (a) and
(d) of Article V of the Constitution and By-laws of the Papago Tribe of
Arizona as amended, ratified by the Papago Tribe on December 12, 1936, and
approved by the Secretary of the Interior on January 6, 1937, pursuant to
Section 16 of the Act of June 18, 1934 (48 Stat. 984). Said Resolution is
not subject to review by the Secretary of the Interior and is effective as of
the date of its enactment by the Papago Council.
