RESOLUTION OF THE PAPAGO TRIBAL COUNCIL

(Waiving Levy of Taxes Imposed under Ordinance No. 03-81 upon) (Contractors Contracting Papago Housing Authority Projects (Az. 26-20 and 26-21. RES. NO. 12-82

1	WHEREAS,	the Papago Council did by Ordinance No. 03-81, enact on September
2		3, 1981, levy and impose privilege taxes upon prime contractors
3		engaging in business on the Papago Reservation measured by the
4		amount or volume of business transacted thereon; and
5	WHEREAS,	the Ordinance provides that such taxes are imposed upon gross
6		income derived from such business after October 1, 1981; and
7	WHEREAS,	the Ordinance provides that it take effect when "approved by
8		the Superintendent of the Papago Agency"; and
9	WHEREAS,	the Superintendent did by letter dated September 11, 1981, advise
10		the Council that he had disapproved the Ordinance, which disapproval
11		was on December 2, 1981, rescinded by the Area Director of the
12		Bureau of Indian Affairs, thus making the Ordinance effective on
13		that date; and
14	WHEREAS,	the Papago Housing Authority officially advertised two construction
15		projects (Az. 26-20 for 12 Elderly Rental Units, and Az. 26-21 for
16		144 Mutual Help Homes) for bids on November 17, 1981, prior to the
17		effective date, and without notice of the Ordinance; and
18	WHEREAS,	the imposition of the privilege taxes without prior notice thereof
19		to bidding contractors would impose an unfair burden upon such
20		contractors, and the Papago Housing Authority has, at the suggestion
21		of the Department of Housing and Urban Development, submitted a
22		request that the requirements of Ordinance No. 03-81 be waived with
23		respect to these two projects.
24	NOW, THE	REFORE, BE IT RESOLVED by the Papago Council that it does hereby
25		waive the requirements of Ordinance No. 03-81 and the levy of taxes

imposed thereunder with respect to projects Az. 26-20 and Az. 26-21 of the Papago Housing Authority.

The foregoing Resolution was duly enacted by the Papago Council on the 4th day of February, 1982, at a meeting at which a quorum was present with a vote of 724.5 for; 110.0 against; 313.5 not voting; and 0 absent, pursuant to the authority vested in the Papago Council by Section 2 (f) and (h) and Section 3 (a), (e) and (h) of Article V of the Constitution and By-laws of the Papago Tribe of Arizona as amended, ratified by the Papago Tribe on December 12, 1936, and approved by the Secretary of the Interior on January 6, 1937, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984). Said Resolution is effective as of the date of its approval by the Superintendent
