Baboquivari District 1983 Budget


1 WHEREAS, the Baboquivari District Council has identified the needs of its
2 members and communities; and
3 WHEREAS, the Baboquivari District did on October 12, 1982, prepare a
4 budget to address those needs and adopted a District budget in
5 the amount of \$354,310.01; and
6 WHEREAS, the Baboquivari District has sufficient funds in its IIM Account
7 to cover the proposed budget; and
8 WHEREAS, the Papago Council has reviewed the budget and approves of same.
9 NOW, THEREFORE, BE IT RESOLVED by the Papago Council that it does hereby
10 approve the attached FY 1983 budget of the Baboquivari District
11 and authorizes expenditures in accordance therewith.

12 The foregoing Resolution was duly enacted by the Papago Council on the 15th
13 day of October, 1982, at a meeting at which a quorum was present with a vote
14 of 1148.0 for; 0 against; 0 not voting; and 2 absent,
15 pursuant to the authority vested in the Papago Council by Section 3 (a) and
16 (h) of Article V of the Constitution and By-laws of the Papago Tribe of Arizona
17 as amended, ratified by the Papago Tribe on December 12, 1936, and approved
18 by the Secretary of the Interior on January 6, 1937, pursuant to Section 16 of
19 the Act of June 18, 1934 (48 Stat. 984). Said Resolution is effective as of
20 the date of its approval by the Superintendent of the Papago Agency and is
21 subject to review by the Secretary of the Interior.


