

RESOLUTION OF THE PAPAGO TRIBAL COUNCIL  
(Appointing Task Force for Health Programs)

RES. NO. 135-82

1 WHEREAS, the Papago Council has received from the Executive Health Staff a  
2 proposal for the FY 83 recontracting of the Community Health  
3 Representative Program; and

4 WHEREAS, the Papago Council does not agree with all aspects covered in  
5 the proposal; and

6 WHEREAS, the Papago Council wishes to appoint a task force to review the  
7 proposal and to conduct an evaluation of the health programs.

8 NOW, THEREFORE, BE IT RESOLVED by the Papago Council that it does hereby  
9 appoint the following to review the FY 83 recontracting proposal  
10 for the Community Health Representative Program and to conduct  
11 an evaluation of all the health programs, to wit:

13 The foregoing Resolution was duly enacted by the Papago Council on the 22nd  
14 day of October, 1982, at a meeting at which a quorum was present with a vote  
15 of 912.0 for; 0 against; 236.0 not voting; and 0 absent, pursuant  
16 to the authority vested in the Papago Council by Section 2 (e) and (f) of  
17 Article V of the Constitution and By-Laws of the Papago Tribe of Arizona as  
18 amended, ratified by the Papago Tribe on December 12, 1936, and approved by  
19 the Secretary of the Interior on January 6 1937, pursuant to Section 15 of  
20 the Act of June 18, 1934 (48 Stat. 984). Said Resolution is not subject to  
21 review by the Secretary of the Interior and is effective as of the date of its  
22 enactment by the Papago Council.
