19 Papago Tribe under Section 1 (a) or (b) of Article II of the
20 Papago Constitution and By-laws, as amended, and their applications
21 are approved, as herein above indicated.
- 22 BE IT FURTHER RESOLVED that the Chairman and other appropriate officers of
23 the Papago Tribe reduce this final determination in writing
24 regarding each of the foregoing applications for enrollment in
25 accordance with Section 1 (c) of Article VIII of the Papago Enroll-
26 ment Ordinance; give notice of this Council's determination in
27 accordance with Section 2 (a) and (b) of Article VIII of the Papago
28 Enrollment Ordinance; and place the names of each applicant upon
29 the Tribal Membership Roll in accordance with Article IX of the
30 Papago Enrollment Ordinance.
- 31 The foregoing Resolution was duly enacted by the Papago Council on the 4th
day of November, 1982, at a meeting at which a quorum was present with a vote
32 of 711.0 for; 276.5 against; 160.5 not voting; and 0 absent,

1 pursuant to the authority vested in the Papago Council by Article II and
2 Article V, Section 2 (f) of the Constitution and By-laws of the Papago Tribe
3 of Arizona, as amended, ratified by the Papago Tribe on December 12, 1936,
4 and approved by the Secretary of the Interior on January 6, 1937, pursuant
5 to Section 16 of the Act of June 18, 1934 (48 Stat. 984). Said Resolution
6 is not subject to review by the Secretary of the Interior and is effective
7 as of the date of its enactment by the Papago Council.
