2		the Bureau of Indian Affairs and the School Facilities and						
3		Construction Office to begin the planning and design for						
4		construction of a new high school; and						
5	WHEREAS,	the application for new school construction was delivered to						
6		the Division of School Facilities and Construction Office in						
7		Albuquerque, New Mexico on August 12, 1982; and						
8	WHEREAS,	the planning phase of new school construction requires the						
9		selection of a site for location of proposed construction; and						
10	WHEREAS,	the options for location were presented to the Districts affected						
11		on October 12th and 28th at Public Hearings called for that						
12		purpose; and						
13	WHEREAS,	the Districts affected, unanimously voted to locate the new						
14		high school near existing school facilities at San Simon in						
15		Pisinemo District on October 28, 1982; and						
16	WHEREAS,	the Education Committee voted to endorse and support the site						
17		location chosen on October 28, 1982.						
18	NOW, THEREFORE, BE IT RESOLVED by the Papago Council that it does accept							
19		and support the site location chosen by the Districts.						
20	BE IT FU	RTHER RESOLVED that the Bureau of Indian Affairs is hereby						
21		notified that the Papago Tribal Council wishes the new high						
22		school be located within the Pisinemo District, in the vicinity						
23		of San Simon.						
24	The foregoing Resolution was duly enacted by the Papago Council on the 4th

26	amended, ratified by the Papago Tribe on December 12, 1936 and approved by the Secretary of the Interior on January 6, 1937, pursuant to Section 16 of the Ac

28	of June 18, 1934 (48 Stat.984). Said Resolution is not subject to review by the Secretary of the Interior and is effective as of the date of its enactment
