

RESOLUTION OF THE PAPAGO TRIBAL COUNCIL
(Approving Tribal Bingo Operation in)
(San Xavier District)

RES. NO. 146-82

1 WHEREAS, the Papago Council has enacted the Bingo Ordinance
2 of the Papago Tribe, Ordinance No. 12-82, which became
3 effective on July 14, 1982, and provides for the
4 conduct of tribal bingo games within a District of the
5 Papago Reservation upon the request of its District
6 Council if there is a suitable site within the Dis-
7 trict for a tribal bingo operation; and

8 WHEREAS, the District Council of the San Xavier District did by
9 Resolution No. 11-82-5 request the Papago Council to
10 conduct a tribal bingo operation within the San Xavier
11 District at a site to be identified within the San
12 Xavier Business Park, upon a finding that the conduct
13 of such bingo operation will help alleviate chronic
14 unemployment on the Papago Reservation and will
15 provide critically needed financial resources for the
16 Tribe and the District to support programs which pro-
17 mote the health, education and welfare of the Papago
18 people; and

19 WHEREAS, the Papago Council concurs with the finding of the San
20 Xavier District Council that the conduct of a tribal
21 bingo operation in the San Xavier District will help
22 alleviate chronic unemployment and provide critically
23 needed financial resources for the Papago Reservation.

24 NOW, THEREFORE, BE IT RESOLVED by the Papago Council that it
25 does hereby approve of the conduct of tribal bingo
26 games within the San Xavier District of the Papago
27 Reservation in accordance with sections 6 and 7 of the
28 the Bingo Ordinance of the Papago Tribe provided a
29 suitable site for the conduct of such games can be
30 found within the San Xavier Business Park,

31 BE IT FURTHER RESOLVED by the Papago Council that it does hereby
32 authorize and direct the Chairman and other designated

officials of the Papago Tribe to negotiate a lease for such site with the San Xavier Development Authority, and to submit such lease and recommendations for the operation and conduct of tribal bingo games at such site for review and approval by the Papago Council.

The foregoing Resolution was duly enacted by the Papago Council on the 19th day of November, 1982, at a meeting at which a quorum was present with a vote of 1148.0 for; 0 against; 0 not voting; and 3 absent, pursuant to the authority vested in the Papago Council by Section 2 (e) (f) and (h) of Article V of the Constitution and By-Laws of the Papago Tribe as amended, ratified by the Papago Tribe on December 12, 1936, and approved by the Secretary of the Interior on January 6, 1937, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984). Said Resolution is not subject to review by the Secretary of the Interior and is effective as of the date of its enactment by the Papago Council.
