

RESOLUTION OF THE PAPAGO TRIBAL COUNCIL
(Sells District Budget Amendment - FY 83)

RES. NO. 147-82

1 WHEREAS, on October 15, 1982 the Papago Council did by Resolution No. 130-82
2 approve the attached FY 83 budget of the Sells District in the
3 amount of \$248,600.00 which included an allocation of \$45,000.
4 to each of the four communities within the Sells District
5 (Big Fields, Cowlic, North Villages, and Sells), but did not
6 include the unexpended balances of each community; and

7 WHEREAS, the BIA Papago Agency is refraining from advancing the \$180,000.
8 for the four communities until a resolution is received approving
9 individual community budgets for the four; and

10 WHEREAS, the Sells District Council by Resolution No. 0782 approved the
11 amended total budget for the Sells District FY 83 budget to
12 \$407,306.92, which includes FY 82 carryover for the four
13 community budgets; and

14 WHEREAS, the Sells District has sufficient funds in its IIM Account to
15 cover the amended budget.

16 NOW, THEREFORE, BE IT RESOLVED that the Papago Council does hereby approve
17 the Sells District's FY 83 budget as amended for \$407,306.92
18 to be expended accordingly.

19 The foregoing Resolution was duly enacted by the Papago Council on the 19th
20 day of November, 1982 at a meeting at which a quorum was present with a vote
21 of 1148.0 for; 0 against; 0 not voting; and 3 absent,
22 pursuant to the authority vested in the Papago Council by Section 3 (a) and (h)
23 of Article V of the Constitution and By-Laws of the Papago Tribe of Arizona as
24 amended, ratified by the Papago Tribe on December 12, 1936, and approved by the
25 Secretary of the Interior on January 6, 1937, pursuant to Section 16 of the Act
26 of June 18, 1934 (48 Stat. 984). Said Resolution is effective as of the date
27 of its approval by the Superintendent of the Papago Agency and is subject to
28 review by the Secretary of the Interior.
