ENROLLMENT - DECEMBER

RES. NO. 150-82

1 WHEREAS, the Papago Council has reviewed the recommendations of the Papago

3 of the Papago Enrollment Ordinance, Ordinance No. 05-81, and has

1 NOW, THEREFORE, BE IT RESOLVED that it is hereby determined that the above
2 named applicants are eligible for enrollment as members of the
3 Papago Tribe under Section 1 (a) or (b) of Article II of the Papago
4 Constitution and By-laws, as amended, and their applications are
5 approved, as herein above indicated.

6 BE IT FURTHER RESOLVED that the Chairman and other appropriate officers of
7 the Papago Tribe reduce this final determination in writing regarding
8 each of the foregoing applications for enrollment in accordance with
9 Section 1 (c) of Article VIII of the Papago Enrollment Ordinance;
10 give notice of this Council's determination in accordance with
11 Section 2 (a) and (b) of Article VIII of the Papago Enrollment
12 Ordinance; and place the names of each applicant upon the Tribal
13 Membership Roll in accordance with Article IX of the Papago
14 Enrollment Ordinance.

15 The foregoing Resolution was duly enacted by the Papago Council on the 1st
16 day of December, 1982, at a meeting at which a quorum was present with a vote
17 of 1148.0 for; 0 against; 0 not voting; and 2 absent,
18 pursuant to the authority vested in the Papago Council by Article II and
19 Article V, Section 2 (f) of the Constitution and By-laws of the Papago Tribe
20 of Arizona, as amended, ratified by the Papago Tribe on December 12, 1936,
21 and approved by the Secretary of the Interior on January 6, 1937, pursuant to
22 Section 16 of the Act of June 18, 1934 (48 Stat. 984). Said Resolution is not
23 subject to review by the Secretary of the Interior and is effective as of the
24 date of its enactment by the Papago Council.
