10	WHEREAS, the Papago Council has reviewed the recommendations of the Budget						
11	and Finance Committee as reflected in the attached FY 1983 Papago						
	Tribal Budget, and approves of same, without allowance for merit						
12	pay increases, and approves the expenditure of the sum of \$1,615,260.
