

RESOLUTION OF THE PAPAGO TRIBAL COUNCIL
Amending Section 1, Article II, of Uniform Election Ordinance

RES. NO. 154-82

1 WHEREAS, Section 1 of Article II of the Uniform Election Ordinance, Ordinance
2 No. 03-78, provides that the names of all persons whose applications
3 for membership in the Papago Tribe have been approved by the Papago
4 Council pursuant to Section 3 (c) of Article II of the Papago Enrollment
5 Ordinance must automatically be added to the Official List of
Registered Voters; and

6 WHEREAS, the Papago Council has determined that it is in the best interest of
7 the Papago Tribe that eligible members of the Tribe whose names are
8 not included on the Official List of Registered Voters should register
to vote in tribal elections with their respective Districts.

9 NOW, THEREFORE, BE IT RESOLVED that Section 1, ELIGIBILITY, of Article II of
the Uniform Election Ordinance is hereby amended to read as follows:


10 ARTICLE II - VOTERS

11 Section 1 ELIGIBILITY


12 All members of the Papago Tribe who have reached the age of
13 eighteen (18) years shall be eligible to vote at any election,
14 provided their names appear on the Official List of Registered
15 Voters. The names of persons appearing on the list of eligible
16 voters of the various Districts at the last general election
17 for tribal office shall be automatically included on the Official
18 List of Registered Voters. Persons whose names do not appear on
19 the Official List of Registered Voters may register for listing
20 not less than sixty (60) days prior to the general or primary
21 election with the District Council of their respective Districts.
The District Council shall, if necessary, call special meetings
to act upon such registrations. All such registrations shall
bear the name of the voter, his or her age, home address, and the
District in which he or she will be permitted to vote. If the
District Council should decide that a registrant is a qualified
voter, it shall so inform the Election Board and shall, at least
thirty (30) days prior to the general or primary election,
forward its resolution and the registration to the Election
Board, and such registrant's name shall be added to the Official
List of Registered Voters.

22 The foregoing Resolution was duly enacted by the Papago Council on the 1st
23 day of December, 1982, at a meeting at which a quorum was present with a vote
24 of 1148.0 for; 0 against; 0 not voting; and 1 absent,
25 pursuant to the authority vested in the Papago Council by Section 5 of Article
26 V of the Constitution and By-laws of the Papago Tribe of Arizona as amended,
ratified by the Papago Tribe on December 12, 1936, and approved by the Secretary
of the Interior on January 6, 1937, pursuant to Section 16 of the Act of June
18, 1934 (48 Stat. 984). Said Resolution is not subject to review by the
Secretary of the Interior and is effective as of the date of its enactment by
the Papago Council.
