

RESOLUTION OF THE PAPAGO TRIBAL COUNCIL
Directing Transfer of Funds in IIM District Accounts

RES. NO. 157-82

1 WHEREAS, the Papago Council has this day by Ordinance No. 15-82 allocated
2 funds from the IIM Accounts established pursuant to Ordinances
3 No. 55 and No. 13-82 to each of the various Districts of the
4 Papago Reservation; and

5 WHEREAS, the Papago Council believes that it would be in the best interest
6 of the Papago Tribe that the funds so allocated be transferred
7 forthwith to the respective IIM Accounts of each District.

8 NOW, THEREFORE, BE IT RESOLVED by the Papago Council that it does hereby
9 request the Papago Agency to transfer from the IIM Accounts
10 established pursuant to Ordinances No. 55 and No. 13-82 to the
11 respective IIM Accounts of each District the sums allocated to
12 them pursuant to Ordinance No. 15-82.

13 The foregoing Resolution was duly enacted by the Papago Council on the 1st
14 day of December, 1982, at a meeting at which a quorum was present with a vote
15 of 1148.0 for; 0 against; 0 not voting; and 1 absent,
16 pursuant to the authority vested in the Papago Council by Section 3 (a) of
17 Article V of the Constitution and By-laws of the Papago Tribe of Arizona as
18 amended, ratified by the Papago Tribe on December 12, 1936, and approved by
19 the Secretary of the Interior on January 6, 1937, pursuant to Section 16 of
20 the Act of June 18, 1934 (48 Stat. 984). Said Resolution is effective as of
21 the date of its approval by the Superintendent of the Papago Agency and is
22 subject to review by the Secretary of the Interior.
