WHEREAS, the Papago Council has this day by Ordinance No. 15-82 allocated funds from the IIM Accounts established pursuant to Ordinances No. 55 and No. 13-82 to each of the various Districts of the Papago Reservation; and

WHEREAS, the Papago Council believes that it would be in the best interest of the Papago Tribe that the funds so allocated be transferred forthwith to the respective IIM Accounts of each District.

NOW, THEREFORE, BE IT RESOLVED by the Papago Council that it does hereby request the Papago Agency to transfer from the IIM Accounts established pursuant to Ordinances No. 55 and No. 13-82 to the respective IIM Accounts of each District the sums allocated to them pursuant to Ordinance No. 15-82.

The foregoing Resolution was duly enacted by the Papago Council on the \_\_lst day of December, 1982, at a meeting at which a quorum was present with a vote of 1148.0 for; 0 not voting; and 1 0 against; \_ pursuant to the authority vested in the Papago Council by Section 3 (a) of Article V of the Constitution and By-laws of the Papago Tribe of Arizona as amended, ratified by the Papago Tribe on December 12, 1936, and approved by the Secretary of the Interior on January 6, 1937, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984). Said Resolution is effective as of the date of its approval by the Superintendent of the Papago Agency and is subject to review by the Secretary of the Interior.
