ENROLLMENT - DECEMBER

RES. NO. 162-82

1 WHEREAS, the Papago Council has reviewed the recommendations of the Papago

3 of the Papago Enrollment Ordinance, Ordinance No. 05-81, and has

27 NOW, THEREFORE, BE IT RESOLVED that it is hereby determined that the above
28 named applicants are eligible for enrollment as members of the
29 Papago Tribe under Section 1 (a) or (b) of Article II of the Papago
30 Constitution and By-laws, as amended, and their applications are
31 approved, as herein above indicated.
32 BE IT FURTHER RESOLVED that the Chairman and other appropriate officers of

1 the Papago Tribe reduce this final determination in writing regarding
2 each of the foregoing applications for enrollment in accordance with
3 Section 1 (c) of Article VIII of the Papago Enrollment Ordinance;
4 give notice of this Council's determination in accordance with
5 Section 2 (a) and (b) of Article VIII of the Papago Enrollment
6 Ordinance; and place the names of each applicant upon the Tribal
7 Membership Roll in accordance with Article IX of the Papago
8 Enrollment Ordinance.

9 The foregoing Resolution was duly enacted by the Papago Council on the 10th
10 day of December, 1982, at a meeting at which a quorum was present with a vote
11 of 1032.0 for; 0 against; 0 not voting; and 3 absent,
12 pursuant to the authority vested in the Papago Council by Article II and
13 Article V, Section 2 (f) of the Constitution and By-laws of the Papago Tribe
14 of Arizona, as amended, ratified by the Papago Tribe on December 12, 1936,
15 and approved by the Secretary of the Interior on January 6, 1937, pursuant to
16 Section 16 of the Act of June 18, 1934 (48 Stat. 984). Said Resolution is not
17 subject to review by the Secretary of the Interior and is effective as of the
18 date of its enactment by the Papago Council.
