

RESOLUTION OF THE PAPAGO TRIBAL COUNCIL
(Requesting EHS Written Report)

RES. NO. 22-82

1 WHEREAS, the Executive Health Staff has presented testimony concerning
2 employee layoffs and staff and program reorganizations within
3 the Executive Health Staff resulting from federal and tribal
4 appropriation and budget cuts; and

5 WHEREAS, the Papago Council wishes to have the testimony submitted in
6 written form.


7 NOW, THEREFORE, BE IT RESOLVED that the Executive Health Staff develop
8 written report for the Papago Council outlining past and
9 anticipated employee layoffs, program cuts and proposed staff
10 and program reorganizations which will be required to meet
11 past and anticipated reductions in federal contracts and grants.

12 The foregoing Resolution was duly enacted by the Papago Council on the 10th
13 day of March, 1982, at a meeting at which a quorum was present with a vote of
14 948.0 for; 142.0 against; 58.0 not voting; and 1 absent,
15 pursuant to the authority vested in the Papago Council by Section 2 (e) and
16 (f) of Article V of the Constitution and By-laws of the Papago Tribe of
17 Arizona as amended, ratified by the Papago Tribe on December 12, 1936, and
18 approved by the Secretary of the Interior on January 6, 1937, pursuant to
19 Section 16 of the Act of June 18, 1934 (48 Stat. 984). Said Resolution is
20 not subject to review by the Secretary of the Interior and is effective as
21 of the date of its enactment by the Papago Council.
